**GENERAL INSTRUCTIONS**



2. Attach attested copy of DMC last Examination.
3. Four (4) attested recent passport size photographs.
4. Original Bank draft / Bank receipt.
5. One attested copy CNIC/ Domicile Certificate or Father CNIC.
6. Private Candidates are required to get their Admission forms along with requisite documents and photographs signed from Gazetted Officer of the Education Department.
7. **Original Migration Certificate** for fresh private candidates.
8. Incomplete forms shall not be entertained in any case and will be returned at the risk /cost of candidates.
9. Examination Hall will be allotted on the basis permanent address mentioned in the examination admission form. For those who want to be examined in the place other than permanent address should send their own / parent service / resident certificate with the form.
10. The certificate should be countersigned by the Gazetted officer.
